PYB STUDENTS ARE ALSO TRAINED IN CONSTRUCTION FUNDAMENTALS, LEARNING CARPENTRY SKILLS AND BUILDING TECHNIQUES WITH A GOAL OF NATIONAL CENTER FOR CONSTRUCTION EDUCATION AND RESEARCH CERTIFICATION (NCCER). PYB SUCCESSFULLY AIDED 16 STUDENTS WITH ACQUIRING THEIR GED AND 23 STUDENTS WITH ACQUIRING NATIONAL CENTER FOR CONSTRUCTION EDUCATION RESEARCH (NCCER) CREDENTIALING. IN ADDITION, 23 STUDENTS RECEIVED CPR CERTIFICATIONS AND 20 STUDENTS WERE OSHA-10 CERTIFIED.
